Re: RoHS (European Directive 2002/95/EC) Reviewed Products

This is to confirm that the products listed below are not intentionally manufactured with any of the noted substances (Lead, Mercury, Cadmium, Hexavalent Chromium, polybrominated biphenyls (PBB) or polybrominated diphenyl ethers (PBDE)) in European Directive 2002/95/EC (also called the RoHS directive). Further, if any of the noted components were present, they would be at only trace levels [less than 20 ppm] as an impurity, significantly below the established maximum concentration values of the Commission Decision 2005/618/EC of 18 August 2005, amending Directive 2002/95/EC.
